4. Sealed bids must be submitted to the office Bahudarmal Municipality, Bahuwari Pidari, Parsa by hand on or before 12:00 Hrs Noon on 22nd January 2024 (2080/10/08). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 Hrs Noon on 22nd January 2024 (2080/10/08) at the office of Bahudarmal Municipality, Bahuwari Pidari, Parsa. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security as mentioned above which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Bid Security, the cash should be deposited in given below bank details and submit the receipt of the deposited amount of cash along with the Sealed Quotation.

8. Any provision which is not mentioned in this notice will be consistent with PPA 2063 and procurement regulation 2064 of Nepal.
9. Supplying health equipment's and drugs must have minimum 18 months expiry validity and for health equipment's and drugs which haven't expiry validity period up to 18 months from manufacturing date, for those health equipment's and drugs expiry validity must be 75% of validity Periods at time of admittance.
10. The quantity of health equipment's and drugs can be changeable as per requirements but the bidder's quoted price of health equipment's and drugs should be same or constant.
11. There must be written "Supply for Ministry of Health" or (11) (1111) (11111) (1111) (1111) on cover of medicine and drugs. Bidders are not allowed to bid more rates than Msp.
12. Supplying medicines and drugs should be WHO GMP Certified and must contain Expiry Date and Batch No. on its cover.
